Volunteer Agreement

In consideration of this opportunity to volunteer, I agree to the following terms and conditions, intending to be legally bound by them:

1. I will abide by the mission, rules, regulations, policies and programs of the Charity while I am a volunteer.
2. If I stop being a volunteer for the Charity for any reason, or upon the Charity's request at any time, I will promptly return all of the Charity's supplies, equipment, records, moneys, and other items in good, clean condition.
3. I assume the risk of being bitten, scratched, injured, frightened or contracting illness by birds in connection with my volunteer work for the Charity. Charity is not liable to me for any injuries, damages, liabilities, losses, judgments, costs or expenses whatsoever, which I might suffer or sustain in connection with the performance of my volunteer activities for the Charity, unless they are the result of the Charity's gross negligence or intentional misconduct. I will indemnify, defend and hold the Charity harmless from and against any claims, lawsuits, injuries, damages, losses, costs or expenses whatsoever, sustained by any companion bird or any person in connection with my intentional misconduct or grossly negligent performance of volunteer activities for the Charity, or my breach of Charity's rules, regulations, policies and programs.
4. I understand and agree that the Charity may refuse volunteer applications for any reason.
5. If I will be sheltering or providing foster care or boarding any of Charity's animals in my home or business, I consent to the Charity visiting my home or business from time to time to observe birds and their living quarters.

- 6. I grant / do not grant permission to The Bailey Foundation to use photographs or likeness of me in publications produced by the Charity and our website.
- 7. I have accurately and truthfully completed this Volunteer Application and Agreement.
- 8. Any modification to this Agreement must be in writing signed by both parties. This Agreement is binding upon the Charity, me, and the Charity's and my respective heirs, successors, assigns, executors, and personal representatives.
